

ELECTION OF THE MANAGING COMMITTEE FOR 2022-2024

ELECTION RULES

(FOR MEMBERS ONLY)

1. The Executive Committee will consist of 13 (THIRTEEN) members to be elected by the general body every two years at its Annual General Meeting.
2. **ELIGIBILITY FOR CANDIDATES / VOTERS:**

- A. Only those members whose names appear in the list of members as on **31/03/2022** under the heading “**MEMBERS ELIGIBLE TO VOTE**” can contest the election. Further, such members who want to contest the election should also pay the membership for the 2 years term in advance for which the election is held.
- B. Only such members who have paid the subscription\membership up to **31/03/2022** have the right to vote in the election.
- C. Only the proprietors in case of proprietary concerns, partners in case of partnership firms, directors in case of Private/Public limited concerns, and office bearers in respect of Association or Co-operative societies and whose names appear in the list of members can exercise their vote and contest the election. The paid employees, though nominated as authorized Representatives, shall not be eligible to contest the election. There shall be only one contestant/voter from each member.

3. **PROCEDURE FOR HOLDING ELECTION :**

The Hon. Secretary of the Association shall display the election program on the notice board of the Association and shall also by circular notify to the members of the election to be held.

- A. The election shall be held by secret ballot system by the members eligible to vote present in the General Body Meeting. Voting by

PROXY will not be permitted. Each members shall vote for the number of candidates to be elected to the Executive Committee.(13 Number).

- B. The votes cast will be counted and the result shall be declared by the Chairman/Returning Officer presiding over the meeting which can not be challenged. The members who have obtained highest number of votes shall be deemed to have been elected. If there is a tie, the decision will be taken by drawing lot.
 - C. In case the number of contestant is less than the strength of the members fixed for the Executive Committee which is **13 (THIRTEEN)** now, but not less than 6 after declaring them elected unopposed, the remaining seats shall be filled by nominations by those members declared elected. The members so nominated shall be considered At par with those elected in all respect. In case the number of contestants is less than 6, election will be required to be held again.
- 4. A candidate wishing to contest the election to the Managing Committee for 2022-2024 should file his nomination in the attached form up to **3.00 P.M. on 29th March'2022 (Tuesday)**
 - 5. Nomination form should be filled in and signed by the proposer, the seconder and the candidate whose name appear in aforesaid Electoral Roll under the heading "**MEMBERS ELIGIBLE TO VOTE**".
 - 6. **No member can propose or second more than 2(two) candidate.**
 - 7. Nomination form will be scrutinized by the Presiding Officer in meeting at **3.00.P.M. on 30th March'2022 (Wednesday)**. Only the candidates contesting election will be allowed to be present at the meeting and to raise objections, if any, on nominations. They can submit their grievance before the Presiding Officer then and there and obtain decision on the spot. The decision of the Presiding Officer shall be final and binding.
 - 8. List of candidates whose nominations have been found valid will be displayed on the notice board for the information of members during office hours in the Associations Office after **5.00.PM on 30/03/2022 (Wednesday)**
 - 9. Withdrawal is permitted up to **4.00 P.M. on 31.03.2022 (Thursday)**.

10. Election time will be from **8.00 A.M. to 2.00 P.M. on 10/04/2022 (Sunday)** and the result will be declared after counting of votes is over by the Presiding – cum – Returning Officer.
11. In order to conduct free and fair election, all members are requested to kindly bring the **Photo identity Card issued by the Association / PAN card or other photo identity card issued by Central / State Government.**
12. A Statement showing the attendance of the Managing Committee Members in the Executive Committee Meetings held for **2018-19, 2019-2020, 20-21, and 2021-22** is attached herewith.
13. Points on which scrutiny of nomination will be based.

Scrutiny of nomination forms will be based mainly on the following points

- **To verify that the nomination form has been received in time and that full membership fee has been paid for next two years.**
- **To verify that the Candidate, the Proposer and the Secunder are the Authorized Representative of the members and that their names and the names of the members they represent, appear on the Electoral roll under the heading “members eligible to vote”**
